**SHORT NEWS PARAGRAPHS.**

Orleans, Oct. 6.—This region Friday the center of cyclonic forces, at least three of which tornadoes and caused the loss of lives, with nine persons fatally injured. About daylight heavy storms swept through the country within 100 miles west, north and east of New Orleans. Reports of sugar cane and crops blown down or sugar cane demolished are coming in from all directions. The damage, in that done in New Orleans, is estimated at over \$1,000,000. The worst was north of New Orleans, and devastated portions of three parishes. New Orleans was visited by another tornado, and another northward of Biloxi, on the coast.

The first tornado struck east of the Rouge parish, killing Mrs. Forel and her daughter, white. Mrs. Forel's body was found in a field near her demolished home. Two children in Mrs. Forel's family were fatally injured and five others injured in the fall of a refinery on St. Delphine plantation. The city of Baton Rouge was damaged. In St. James parish a man was killed, while Mrs. Harper and daughter and Mrs. Sawyer and a negro were reportedly injured. Fifteen buildings were blown down in this parish. At Bayou George Hawes and son were killed in the collapse of their home and the two other children of the family were fatally injured. Another person was injured.

Another tornado struck New Orleans about 8 o'clock. While no lives were lost here, the property damage was \$50,000 and about 50 persons injured. Fully 800 buildings were damaged, about 75 of which were blown flat. Most of the demolished buildings were negro cabins, as here that the injured live.

**Of Former Resident of Wooster on Friday.**

**Was Eighty-Two Years Old. Came to Wooster From Pennsylvania in 1882.**

On Friday word was received here of the death of a former citizen of Wayne county, Michael Eyman, who died Friday morning at Homerville Medina county. While his death was not unexpected as he had been in bad health for months, it will prove a source of much regret and profound sorrow to the family and quite a large circle of friends both in Wayne and Medina counties, and elsewhere where he was known. Mr. Eyman was a devout Christian a more than ordinarily kind and loving father and husband.

Mr. Eyman was born in Pennsylvania but came to this county with his parents in 1832 and grew to manhood on a farm a few miles west of Wooster. Several years ago, however, he moved to Medina county, where he has since lived. He was in his 32d year and a twin brother, Christian Eyman, preceded him but a few months having died in Montana on May 12th last. He leaves a wife whose maiden name was Miss Harriet Swinehart, and three children, one son, David Eyman of Lorain, and the Misses Mary and Millie Eyman, who reside at their home near Homerville.

Mr. Eyman was one of a family of nine children, all of whom are now deceased but two, Adam Eyman and Mrs. Wm. Albright, both of Wooster.

The funeral services will take place from the home on Sunday at 1 p. m.
